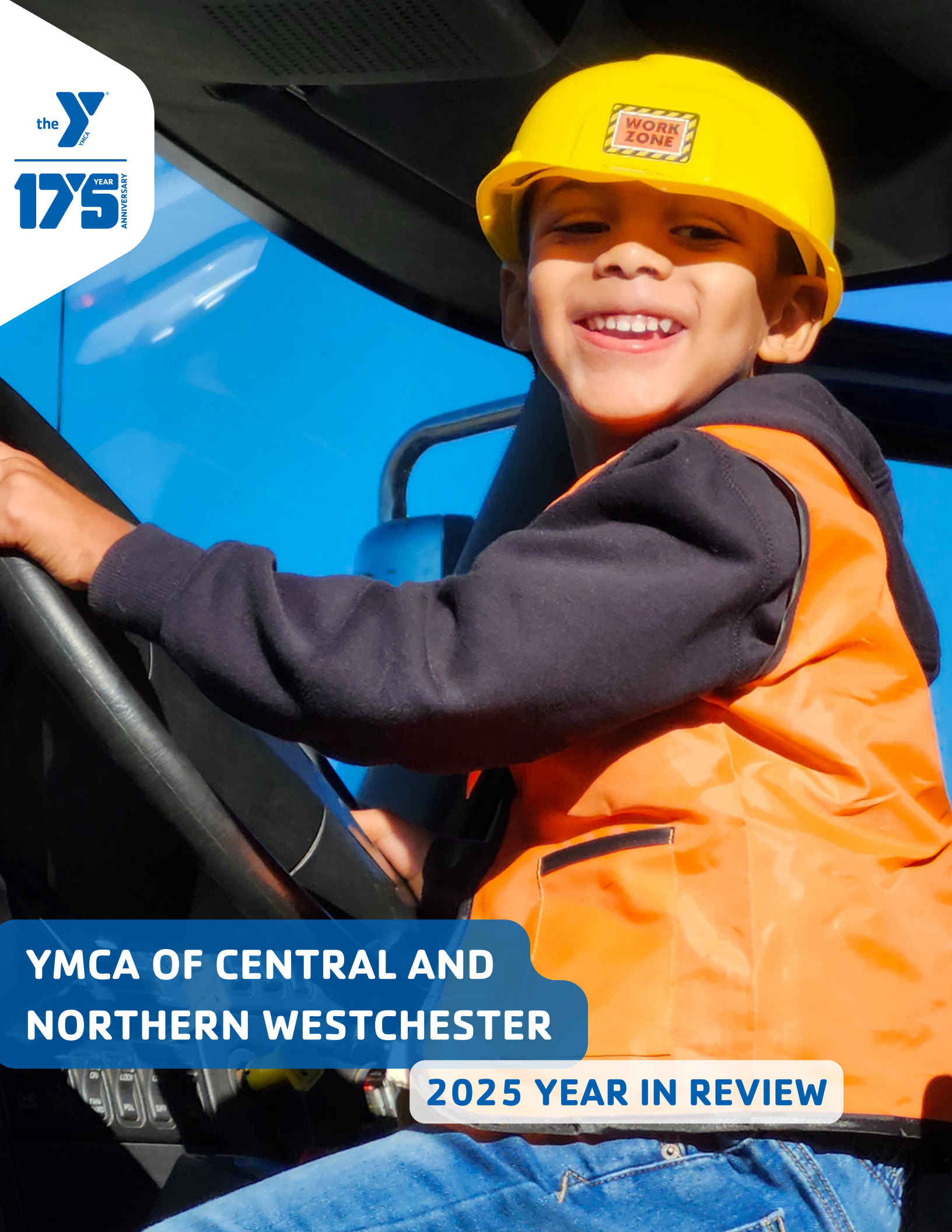

- 68 children learned, played, and grew in our YMCA Early Learning Centers.
- We proudly served 884 Universal Pre-Kindergarten students across 12 school districts.
- 902 children, across 8 school districts, found support, enrichment, and fun in our before and after-school programs.

98 teens found their voice, built leadership skills, and made lasting memories through YMCA teen programs.
